STUDENT AND SUPERVISOR AGREEMENT

4. Any work performed for client cases is protected under the attorney/client privilege and will be kept confidential by the student. Such work will not be discussed with any person without the permission of the supervising attorney.
5. The student and the supervising attorney have discussed the public service work to be performed, have conducted a reasonable inquiry into the issue of actual and potential conflicts of interest pursuant to the Kentucky Rules of Professional Conduct 1.7 et. Seq., and have determined that no conflicts of interest exist with regard to the student's performance of the public service work.
 - The student and any entity that the student owns or controls do not have a financial interest or any economic relationship in the placement.
 - The student and any entity that the student owns or controls have not received anything of value from—or have not been promised anything of value by—any person or entity appearing to have an interest in the proposed public service work.
 - The facts found or results obtained through the proposed public service work will not have a direct financial effect upon the student.
 - Any legal or law-related work that the student has performed in the past or is currently performing for the placement or for any other entity will not pose the possibility of a conflict of interest with the proposed public service work.

Should the circumstances listed above change while the proposed public service work is pending or after the public service work is underway, the student will promptly notify the Public Service Program Director and the supervising attorney.
